### PATENT CLEARANCE PROCESS

Patent clearance **MUST BE** obtained for conference abstracts, conference papers (even if the conference abstract has been patent cleared previously), poster papers, PPPL Reports, Theses, PPPL Technical Memos, and journal papers before presentation and/or publication. When a scientific paper is patent cleared, it is listed automatically on the Laboratory's Publication List and the authors' bibliography.

#### PPPL Reports

It is strongly encouraged that all research papers be issued in preprint form as a PPPL Report. PPPL Reports are posted to the Laboratory's Publications and Reports web site ([http://www.pppl.gov/pub\\_report](http://www.pppl.gov/pub_report)), making the information immediately available to everyone, and sent to the U.S. Department of Energy's (DOE) Office of Scientific and Technical Information for inclusion in the DOE Information Bridge (<http://www.osti.gov/bridge/>). The DOE Information Bridge is one of the ways DOE makes its laboratories' research results accessible to scientific communities, government officials, and the public.

To patent clear a PPPL Report, the Patent Clearance and Publication Approval Form and the Subject Indexing Form (used by the PPPL Library for cataloging the paper) must be completed and approved and an electronic file of the paper provided.

The preferred electronic file format is postscript, but other file formats such as word processor files (Microsoft Word), PDF files, and drawing program files are acceptable.

Electronic files can be sent as an attachment to an e-mail message to Carol Phillips at [caphilli@pppl.gov](mailto:caphilli@pppl.gov) or "fetched" by Publications and Reports (P&R). To fetch a document from a PC or Macintosh, the file name, AppleTalk zone, and file server name must be provided. From the UNIX, the full path name to your file is needed.

Send the approved Patent Clearance and Publication Approval Form, Subject Indexing Form, and a copy of the document to be patent cleared to the P&R Office, B378, MS38.

#### Non-PPPL Documents

If a document will not be issued as a PPPL report, complete the Patent Clearance and Publication Approval Form, have it signed by your Division Head, attach a copy of the document to be patent cleared and send to P&R, B378, MS38.

#### Page Charges and Reprints

There are usually page charges and reprint fees associated with publishing a paper. When these forms are received by the author, they should indicate the number of reprints they want to order and send the form to P&R, B378, MS38. **DO NOT COMPLETE THE FORM.**

#### Copyright

When copyright forms are received by the author, please send them to P&R, B378, MS38. A signed copyright form will be returned to the author. The author should complete this form and send it to the publisher.
